- 2. Selections must be made from the following combinations:

(a) Four or five numbers.

(b) Two, three or four numbers followed or preceded by a single initial.

(the letters I, O or Q may not be used in this series.)

(c) One, two or three numbers preceded or followed by two initials. (the letters I, O or Q may not be used in this series when such letters immediately precede or follow the numerals)

(d) One or two numbers preceded or followed by three initials. (the letters I, O or Q may not be used in this series when such letters immediately precede or follow the numerals);

(e) When two or three letters are used, they may not be separated by numbers and sim-

ilarly, numbers may not be separated by letters.

3. Radio and Television stations will be issued special plates containing the station call

letters assigned by F.C.C.

- 4. No special registration plates will be duplicated, except when defaced or lost. In such cases the charge for replacement will be \$1.00.
